If you receive a Notice of Violation, the Notice will indicate if you have the option of paying a fine or appearing at a hearing, OR, that there is a mandatory hearing. If the fine is not paid as indicated on the Notice of Violation, the hearing will be held as scheduled whether or not you or a representative are present.

More restrictive water conservation measures may be put into effect if severe drought conditions are determined to exist by the South Florida Water Management District.



Town Ordinance Fine Schedule For

1st Offense = \$75
2nd Offense = \$125
3rd Offense = \$250
4th Offense = \$500
Subsequent Offenses = \$500
or a mandatory hearing

LANDSCAPE IRRIGATION

Per Section 122-78 of the Town of Palm Beach Code of Ordinances, irrigation is prohibited from 9:00AM to 9:00PM every day and no irrigation is allowed on Friday at any time.

Irrigation System usage for EVEN numbered addresses North of Southern Boulevard

Lawn watering is permitted on SUNDAYS, TUESDAYS, and THURSDAYS from 12:01 AM to 9 AM, **OR**, from 9 PM to 12 AM. **NOT DURING BOTH TIME PERIODS**

Irrigation System usage for ODD numbered addresses North of Southern Boulevard

Lawn watering is permitted on MONDAYS, WEDNESDAYS, and SATURDAYS from 12:01 AM to 9 AM, **OR**, from 9 PM to 12 AM. **NOT DURING BOTH TIME PERIODS**

Irrigation System usage for properties on the WEST side of South Ocean Boulevard, South of Southern Boulevard

Lawn watering is permitted on SUNDAYS, TUESDAYS, and THURSDAYS from 12:01 AM to 9 AM, **OR**, from 9 PM to 12 AM. **NOT DURING BOTH TIME PERIODS**

Irrigation System usage for properties on the EAST side of South Ocean Boulevard, South of Southern Boulevard

Lawn watering is permitted on MONDAYS, WEDNESDAYS, and SATURDAYS from 12:01 AM to 9 AM, **OR**, from 9 PM to 12 AM. **NOT DURING BOTH TIME PERIODS**



NEWLY PLANTED LANDSCAPING & SOD

You can avoid receiving a Notice of Violation for watering newly planted sod or landscaping by providing documentation of the new planting, including the date of installation, to the Code Enforcement Unit. A copy of the invoice or other documentation may be sent or dropped off at the Police Department at 345 South County Road, Palm Beach, or may be faxed to the Code Enforcement Unit at 561/835-4736. If you have not provided the documentation and receive a Notice of Violation, please call the Code Enforcement Unit at 561/227-7080 for instructions. With proper documentation, the Notice of Violation will be rescinded.

Newly Planted Landscaping & Sod

All Property Sizes:

In place from the first day to 45 days: Monday, Tuesday, Wednesday Thursday, Saturday AND/OR Sunday (any days except Friday): 12:01 AM to 9 AM AND/OR 9 PM to 12 AM

Installation of new irrigation systems must include water sensing devices

POWER OUTAGES

Power outages may effect irrigation timers which do not have a battery backup. If you receive a Notice of Violation for water use, and you believe that the violation occurred due to a power outage, you can request documentation from Florida Power & Light. Call FPL at 561/697-8000, and request the documentation. Then call the Code Enforcement Unit at 561/227-7080 to provide the details. If the violation occurred within 7 days of a documented power outage, the Notice of Violation will be rescinded.

Activities Permitted on a Daily Basis in any area:

- Hand watering, using a self-canceling nozzle

Activities Permitted on a Temporary Basis:

- Watering in fungicides, insecticides, and herbicides by licensed pest control operators provided a temporary sign is posted with the date of application and date(s) of needed "watering in" activity.
- Operation of irrigation systems during cleaning, maintenance or repair may be operated once a week if an attendant is on site in the area being tested. Testing should not exceed 10 minutes per zone.
