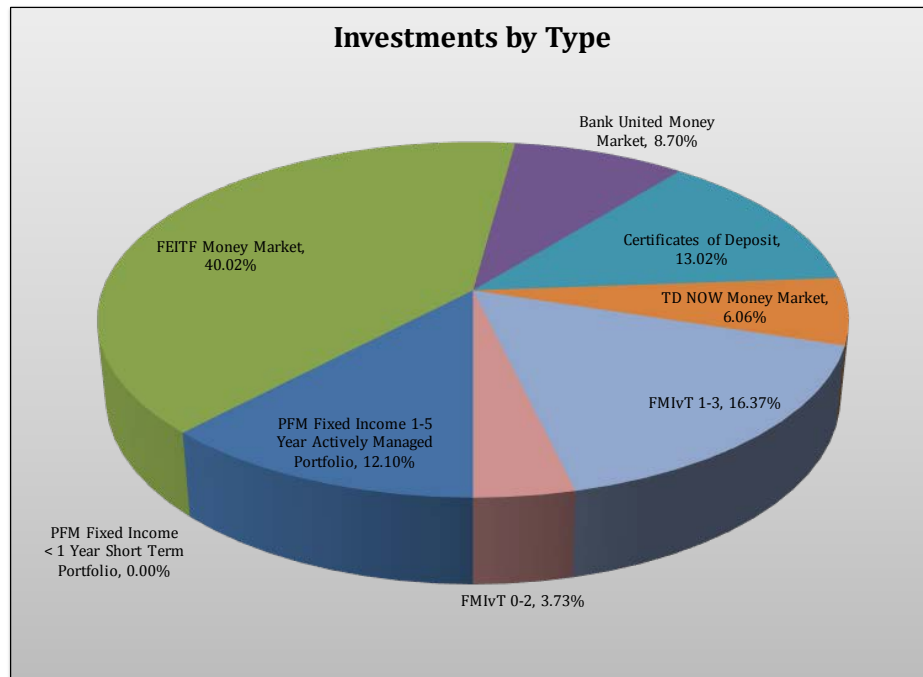

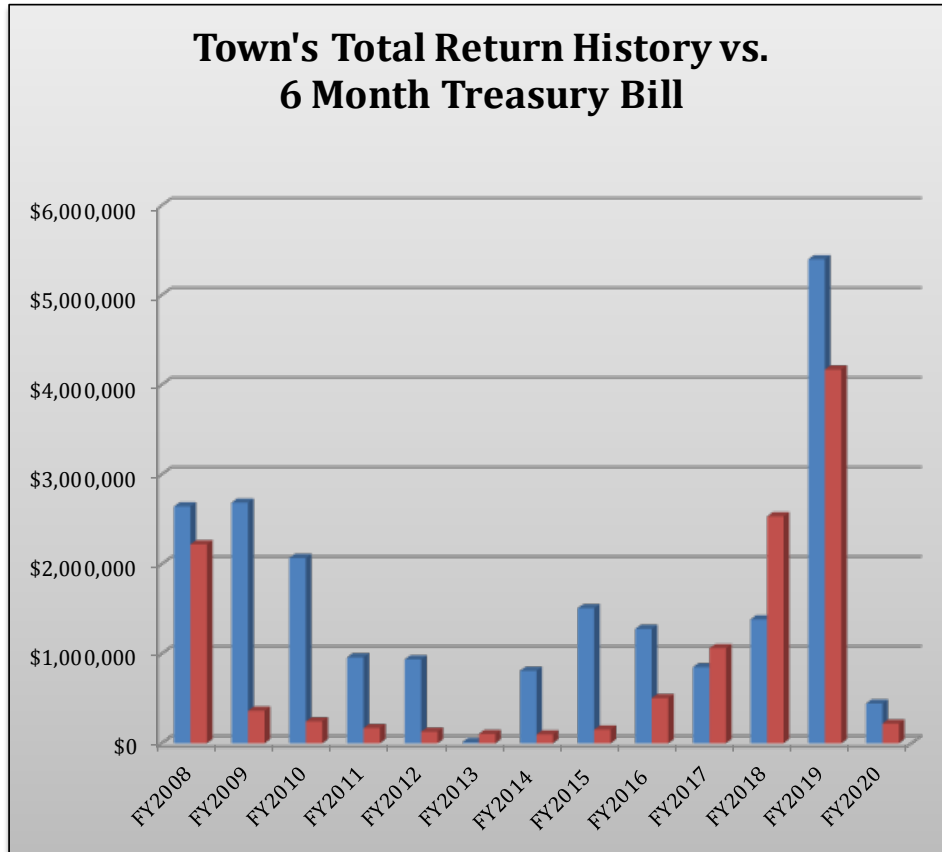

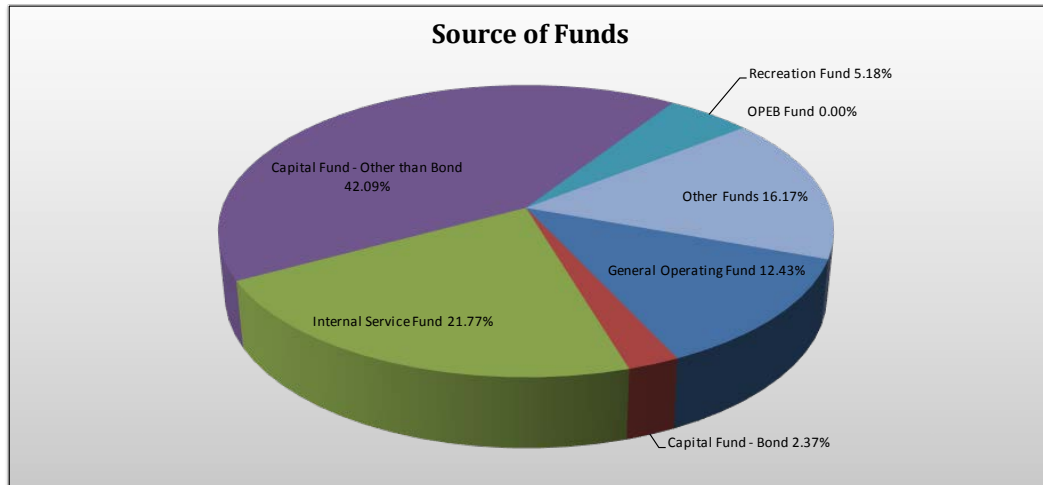


Town's FY2020 Monthly Investment Return vs. 6 Month Treasury Bill

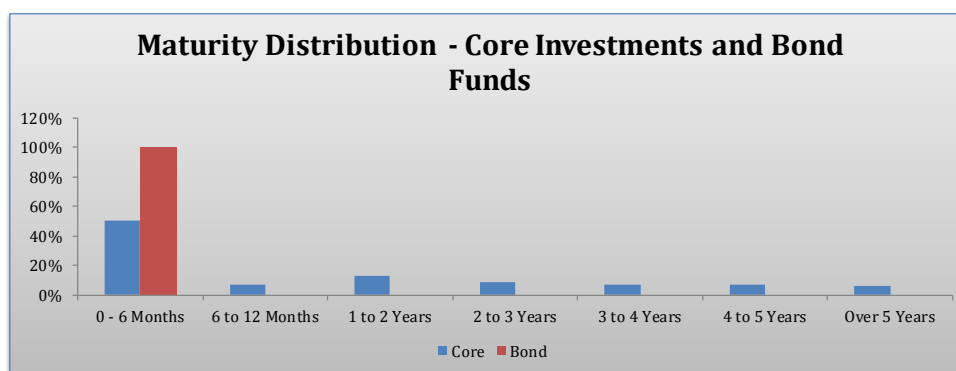
