# MORTON AND BARBARA MANDEL RECREATION CENTER

## Reopening Plan with Phase 1 Guidelines

The Smith Family Fieldhouse reopened on Tuesday, June 9, for use by reservation only. Please read all procedures and guidelines before reserving the pickleball court or the half basketball court. The Game Room remains closed to the public. The Café is open. The Fitness Center is open for resident members only by appointment.

The following guidelines are procedures all participants should read through prior to making a reservation for pickleball or the half basketball court at the Smith Family Fieldhouse within the Mandel Recreation Center:

1. You may reserve the pickleball court or the half basketball court by calling 561-838-5485.
2. You may make your reservation for a one or two hour block, the cost per hour is \$25/resident/\$32 non-resident plus tax for pickleball and \$20 resident/\$25 non-resident plus tax for half-court basketball. These prices are the total cost for the whole half side of the fieldhouse, there is no per person cost. Pickleball singles and doubles play is allowed, basketball may have up to 6 players.
3. Hours for the Smith Family Fieldhouse will be Monday through Friday 8:30am to 6:30pm, and Saturday and Sunday 10-4pm.
4. You must bring your own equipment (basketballs, paddles, balls, etc.).
5. Please arrive no earlier than 10 minutes before your scheduled time.
6. Reservations may be made up to one week in advance, multiple reservations are allowed.
7. Please bring your own water.
8. Bleachers will be pushed in and not available for use.
9. It is preferred that you pay in advance by calling 561-838-5485.
10. You must pay in advance by calling 561-838-5485. No refund if canceled within 24 hours of reservation time.
11. All participants are required to complete Town of Palm Beach waivers before participating.

# SEAVIEW PARK AND PHIPPS OCEAN PARK TENNIS CENTERS

## Reopening Plan with Phase 1 Guidelines

The Seaview Park and Phipps Ocean Park Tennis Centers reopened Friday, May 1, with a devoted strategy to ensure the well-being of patrons and staff through strict adherence to CDC guidelines and implementation of specific procedures for COVID-19 safety.

RESIDENTS with Annual, Seasonal or Play Passes can reserve one court up to 2 days in advance beginning at 12pm, RESIDENTS without a pass and NONRESIDENTS with Annual, Seasonal or Play Passes can reserve one court up to 1 day in advance beginning at 12pm. You should call 561-227-7081 to book the courts at Seaview and 561-227-7082 to book the courts at Phipps. If you are unfamiliar with the current reservation guidelines, please review them here:

### Tennis Operation Requirements:

1. Singles and doubles play is permitted. No congregating on the court or sidelines is permitted.
2. For Seaview Park, the restrooms on the east side of the Mandel Recreation Center by the playground will be available for use. The restrooms at both centers will be regularly cleaned and disinfected throughout the day.
3. Court reservations and payments will only be taken over the phone, the pro shop will be closed to the public.
4. Signage will be posted with the pro shop phone number on the door and near the walkway for walk-ins to call, reserve, and pay over the phone prior to playing.
5. No merchandise or refreshments will be sold other than tennis balls, which should be ordered over the phone during the reservation process.
6. Players should arrive no more than 10 minutes prior to their court time.
7. Water fountains will not be in use. Please bring your own water.
8. Stringing and re-gripping: client will put their racquet in a plastic bag (supplied) with information and place in basket outside the pro shop. Client will be notified of specific date and time when available for pick-up.
9. All gates onto courts will be propped open and sanitized morning, noon and evening.
10. All score tenders have been taken off the courts.
11. Treadblaster shoe cleaners will not be in use.
12. No demo or rental racquets will be available; everyone needs to have their own racquet.

The following requirements are related to those taking lessons (all requirements above apply as well)

1. Lesson bookings and payments will be done over the phone prior to taking a lesson, only one person lessons are permitted (exception would be same household participants).
2. Clients will not pick up the tennis balls, will not touch any tennis ball hopper or tubes, and hoppers and tubes will be sanitized between uses.
3. Clients will push the balls into the net or into the corner with their racquets to assist pro in collecting tennis balls.
4. No service during lessons. If game is in play, only the pro can serve or feed the ball.
5. When teaching during lesson, keep an appropriate distance of at least 6 feet.
6. No demo or rental racquets will be available; everyone needs to have their own racquet.

## **SEAVIEW PARK**

### **Reopening Plan with Phase 1 Guidelines**

Seaview Park reopened Wednesday, April 29, with a devoted strategy to ensure the well-being of patrons and staff through strict adherence to CDC guidelines and implementation of specific procedures for COVID-19 safety.

#### Operation Requirements:

1. The playground remains closed.
2. Use of water fountains is prohibited.
3. The basketball court is open. Each player should bring his/her own basketball.
4. The court may be utilized for pickleball, you must bring your own portable net and equipment.
5. Congregating in groups of 10 or more is prohibited.



## **PALM BEACH PAR 3**

### **Reopening Plan with Phase 1 Guidelines**

The Palm Beach Par 3 Golf Course reopened Thursday, April 30, with a devoted strategy to ensure the well-being of patrons and staff through strict adherence to CDC guidelines and implementation of specific procedures for COVID-19 safety.

#### Golf Operation Requirements:

1. Play shall be set-up for walking, single rider golf cart, or shared cart for families living in the same household. Staff will verify by ID. Shared carts will be identified by a small colored flag to indicate verified family sharing.
2. Players shall not arrive earlier than 45 minutes prior to tee times.
3. Staff will not handle golfer's bags, clubs, or other equipment, or transport these items at any time to and from the parking lot. Players will be responsible for bringing their golf equipment to the designated areas.
4. Al Fresco open with seating capacity restricted, also open for takeout.
5. Golfers are encouraged to utilize prepayment options by calling 561-547-0598 or booking through [golfontheocean.com](http://golfontheocean.com). Pre-paid rounds are checked outside by the starter and they will direct you when to proceed to the first tee. If a golfer is unable to pay online, payment will be made in compliance with CDC guidelines. Temporary Plexiglass is setup at the counter to provide a partial barrier. Traffic will be setup as one way (entering from north doors), for those who must enter the building to pay, 6' spacing markers will be placed. Signs will be in place to direct appropriate traffic flow.
6. Tee times will be setup with 10 minute tee intervals for purposes of social distancing.
7. Food and beverage carts are not allowed.
8. Cups have been raised so the ball does not drop and players will be informed not to touch or remove flagsticks from the cups at all times.
9. Rakes in all bunkers have been removed, golfers should play preferred lie and "rake" with their feet.
10. All sand containers, scorecards, pencils, tees, towels, and other shared materials have been removed from the carts. Scorecards and pencils will be available upon request from the starter.
11. There will be no ball washers available for use.
12. When playing, golfers shall practice social distancing per the CDC guidelines.
13. Club restrooms will be cleaned and disinfected regularly throughout the day.

14. The touchless water fountain will be available for use, but golfers are still encouraged to bring their own water; restrictions are lifted for personal coolers containing water.
15. Golf carts and pull carts will be cleaned and disinfected after each round.
16. Players shall not congregate after play and shall leave the facility immediately upon completion of play.
17. Valet service suspended until further notice.
18. Golf lessons are now allowed.
